As and when we have new contractors or suppliers come on-board, we pre-qualify any new company or sub-contractor through a series of diligence, relating to company performance, HS&E compliance and references from other customers to establish that they are suitable.

We always monitor, assess and mitigate the potential risk areas in our supply chains and have robust systems in place to deal with such risks.

To date, we haven't been made aware of any human trafficking or slavery activities within the supply chain, but if any were highlighted to us, then we would act immediately in accordance with our legal and moral obligations.

DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING

As part of our initiative to identify and mitigate risk, we have in place systems to

- Identify and assess potential risk areas when considering taking on new suppliers and regularly review our existing supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistleblowers

TRAINING

We have zero tolerance to slavery and human trafficking. To maintain awareness and ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we aim to develop training for our staff.
